Borrower-Mortgagor Mr Raj Kumar Thakur S/O-Sri Mahabir Thakur ,41/1A, Manujendra Dutta Road, Kolkata-700028, availed credit facility from Indian Bank, **South Sinthi Branch**, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Raj Kumar Thakur**, failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **19.02.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) / Guarantor(s) **Mr. Raj Kumar Thakur** and **Mrs Sudha Devi** liable to the Bank to pay the amount due to the tune of **Rs. 17,19,827.00 (Rupees Seventeen Lacs Nineteen Thousand Eight Hundred and Twenty-Seven only) as on 19.02.2026** with further interest, costs, other charges and expenses thereon. All failed to make payment despite Demand Notice dated 19.02.2026.

As Mr. Raj Kumar Thakur and Mrs Sudha Devi failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 25.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. 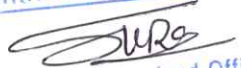
