- This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.

2. Please refer to the possession notice dated 15.12.2025 issued to you regarding taking possession of the secured assets at more fully described in the schedule below and the publication of the said possession notice in JANSATTA (Hindi daily) and FINANCIAL EXPRESS (English daily) on 17.12.2025 by the undersigned for the purpose of realization of the secured

You the above named borrowers / mortgagors / guarantors have failed to pay the dues in full save and except payments amounting to Rs. 946/- (Rupees Nine Hundred Forty Six Only) after issuance of demand notice dated 09.07.2025.
