

SHIMLA: SCHOOL'S EXECUTIVE MURDER

Police arrest 2 from Haryana, victim's brother says he was attacked too

TWO DAYS after the murder of Manisha Mittal (41), the executive of Saraswati Paradise International Public School (SPIPS), in Sanjauli, the Shimla police Monday arrested two accused from Haryana, allegedly responsible for the shooting on Saturday. Meanwhile, Shimla continues to reel under the murder, with the school still shut and parents worried about their children's education and safety.

Police have identified the accused as Ashish Ahlawat (22), a resident of Jhajjar district, and Deepak Budhwal (25), a resident of Rohtak district in Haryana. Both shooters have criminal backgrounds, ASP (Shimla) Abhishek said.

On the other hand, the multi-storey school, which serves nearly 900 students, looked deserted on Monday.

Instead of children and teachers, police occupied the premises, conducting investigations into what has emerged as one of the most sensational murder cases in recent years in the state capital. Bloodstains still mark the red-tiled entrance where the murder took place.

Inside the school, the sole eyewitness, security guard Yash Pal (29), to the murder recalled the sequence of events that unfolded Saturday evening. The guard said that his first call after the incident was to school principal Neeraj Verma.

Manisha Mittal, the eldest daughter of the school's founders, Dharam Pal Mittal and Nutan Mittal, was shot dead on

the last day of the school's eight-day summer vacation.

“The school was scheduled to reopen today, but the incident has changed everything. The management has extended the vacations for another two to three days,” SPIPS Principal Neeraj Verma said.

Baldev Thakur, president of the RWA, Housing Board Colony, said parents were deeply concerned about the incident's impact on students.

One of the parents, requesting anonymity, said, “The government and district administration should intervene and ensure that the education of students does not suffer due to the ongoing developments.”

Meanwhile, Himank Mittal, the victim's younger brother and chairman of the school's management board, claimed, “I was attacked by unknown persons in Rohtak district on June 1 and suffered fractures in my leg and arm. I am currently bedridden.” He accepted the prolonged dispute between him and his sister over the school's management. “In response to my sister's video allegations, I had recorded a video statement on June 10. However, before it could gain attention, my sister was murdered.”

Dr Subhash Yadav, Manisha's husband, said, I received information about my wife's murder from police and have recorded my statement.” He also confirmed that the couple had been living separately for some time.

The ASP also said that the investigators were examining all possible angles.

PSPCL cancels recruitment drive for 6,289 assistant linemen posts

PUNJAB STATE Power Corporation Limited (PSPCL) on Monday cancelled the recruitment advertisements for a total of 6,289 Assistant Lineman (ALM) posts, marking it the second withdrawal in two months.

In a circular issued on June 15, PSPCL said the two separate recruitment advertisements issued on June 7 for 3,289 Assistant Lineman posts and another 3,000 Assistant Lineman posts (both categories with different criteria) stand cancelled with immediate effect.

The registration for the

3,289 ALM posts was scheduled to begin on Monday, while the application process for the other 3,000 posts was slated to start on June 19.

Earlier, PSPCL had advertised 3,000 ALM posts on April 7 and changed the eligibility conditions. It had invited applications from ITI pass candi-

dates in the wireman and electrician trade without having a national apprenticeship certificate. The applications from PSPCL were opposed by the students undergoing NAC, following which the board withdrew them on April 16.

Under the first advertisement for 3,289 Assistant Line-

man posts, candidates were required to have passed matriculation and possess a National Apprenticeship Certificate (NAC) in the lineman trade. The second advertisement for the other 3,000 ALM posts prescribed matriculation along with an ITI certificate in Electrician or Wireman trade from in-

stitutions recognised by the National Council for Vocational Training or the State Council for Vocational Training (SCVT).

Surinder Singh, HSPVP president, said the protesting apprentices are expected to complete their NAC certification in November this year and were therefore ineligible to apply.
