

Iran claims victory, says deal marked US defeat

Trump says Iran dropped plans to charge ships passing via Hormuz

TEHRAN

IRAN called the deal to end the West Asia war “a declaration of America’s defeat” on Wednesday, as US Secretary of State Marco Rubio renewed Washington’s commitment to Gulf security during a regional tour, seeking to reassure allies hit hard by Iran during the conflict.

Iran’s top negotiator Mohammad Bagher Ghalibaf said the Islamabad understanding “was not the result of pressure and coercion, but rather the result of the resistance and authority of the brave Iranian nation”. He said security in West Asia must be ensured by countries of the region and called for “interaction” and “coexistence”.

Rubio reassures Gulf

Rubio held talks with UAE President Sheikh Mohamed bin Zayed in Abu Dhabi before head-

ing to Kuwait and Bahrain. His spokesperson Tommy Pigott said they discussed US Presidential memorandum of understanding with Iran, efforts to secure full and safe transit through the Strait of Hormuz and the importance of peace and stability in the region.



Pigott said Rubio thanked the UAE for its support and “reaffirmed the US commitment to the security of the Emirates”

Trump on Hormuz

Trump wrote on Truth Social that Iran had informed that there were “no tolls, no insurance costs, & no other charges of any kind” on ships travelling through the Strait of Hormuz, though he did not say whether the commitment would outlast the 60-day negotiating period.

Inspection dispute

A week after the US and Iran signed interim deal, differences surfaced over nuclear inspections. International

Atomic Energy Agency chief Rafael Mariano said inspections of Iran’s enrichment sites are going to happen. *AFP*

UN experts accuse Israel of killing children in Gaza

JERUSALEM

A team of independent experts commissioned by the United Nations accused Israel of deliberately shooting children in Gaza and repeated its accusation that Israel has committed genocide in the territory.

Israel has denied claims that it committed genocide during its 2 1/2-year war in Gaza.

The commission said in its report Tuesday that roughly 30% of the Palestinians killed from October 2023 to October 2025 — more than 20,000 in total — were children.

Israel has denied deliberately targeting civilians and

pushed back on accusations, including from rights groups, that it committed genocide in Gaza.

Ukraine struck natural gas plant of Russia

KYIV

UKRAINIAN forces struck a major natural gas processing plant and two key satellite communications centers in their latest nighttime attacks on Russia, Ukraine’s General Staff said on Wednesday. The operation was part of Ukraine’s aerial campaign targeting energy facilities and military industries that has intensified as Kyiv builds bigger and better long-range weapons to ward off Russia’s full-scale invasion, now in its fifth year.

In response, Moscow has ordered the redeployment of some air defense systems from Russian regions to the capital and to Crimea’s Kerch Bridge, a crucial link for supplying Russian troops, Ukrainian President Volodymyr Zelenskyy said. The bridge connects the Crimean Peninsula with the Russian mainland. “It is important that as many Russians as possible come to understand that it is the Russian leadership’s rejection of diplomacy,” Zelenskyy said on X. *AP*

Federal judge bars Prez Trump administration

WASHINGTON

A federal judge on Wednesday permanently barred President Donald Trump’s administration from implementing most of his first executive order on elections, part of which sought to require people to show documentary proof of citizenship when they register to vote.

The ruling by US District Court Judge Denise Casper in Boston effectively converts a preliminary injunction she issued a year ago, in which she temporarily blocked many of Trump’s efforts to overhaul elections, into a permanent ban.

Casper rejected the administration’s argument that the lawsuit to block the changes brought by Democratic state attorneys general was premature because the rules had yet to be implemented. Instead, she agreed that the Constitution gives states. *AP*
