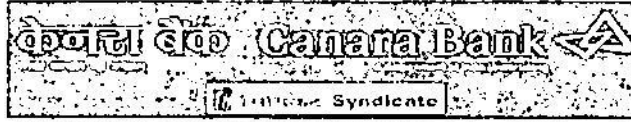

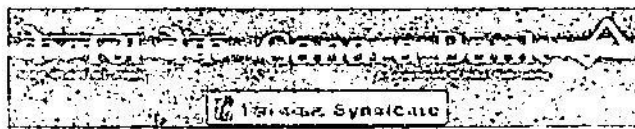

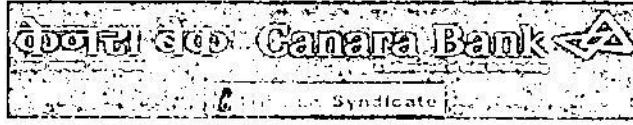

- f. 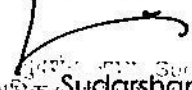
