M/s Sam Trading Co , Mr.Girish kumar PH and Mrs.Chareshma have availed loan facility from Indian Bank, Tirur road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Sam Trading Co , Mr.Girish kumar PH and Mrs.Chareshma failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 15.04.2025 (published on 20.06.2025) under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon M/s Sam Trading Co , Mr.Girish kumar PH and Mrs.Chareshma liable to the Bank to pay the amount due to the tune of Rs.29,71,328.00 (Twenty-nine lakh seventy-one thousand three hundred and twenty-eight only) as on 14.04.2025 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 15.04.2025.

As M/s Sam Trading Co , Mr.Girish kumar PH and Mrs.Chareshma failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 12.09.2025 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 15 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 24.06.2026 is Rs.36,61,410/- (Rupees Thlrty six lakhs sixty one thousand four hundred ten only with further interest, costs, other charges and expenses thereon from 25.06.2026.
