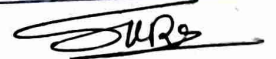

SUJIT MONDAL, VILL-FATEPUR NEAR FATEPUR PRIMARY SCHOOL, PO & PS ULUBERIA ALIPUKUR CT, HOWRAH 711315 availed credit facility from Indian Bank, ULUBERIA Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". 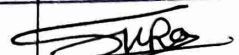
