Therefore, a Demand Notice dated **07.03.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower (s) / Guarantor(s) **Mr. Alope Rit, Mrs. Piyali Rit** liable to the Bank to pay the amount due to the tune of **Rs. 11,85,065.00 (Rupees Eleven Lakhs Eighty-Five Thousand and Sixty-Five only)** as on **07.03.2026** with further interest, costs, other charges and expenses thereon. As **Mr. Alope Rit AND Mrs. Piyali Rit** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 27.05.2026 after complying with all legal formalities.

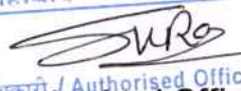
