1. The property(ies) will be sold by e-auction through the Bank's approved service provider <https://baanknet.com/eauction-psb/home> or <https://baanknet.com> under the supervision of the Authorized officer of the Bank.
2. The intending Bidders/ Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/home> or <https://baanknet.com> using their mobile number and email id. Further they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending bidders/ purchasers has to transfer the EMD amount using online mode in his Global EMD wallet account by **22.07.2026** Intending bidders shall have a valid email address and should register their name/ account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/ RTGS mode (after generation of challan from <https://baanknet.com/eauction-psb/home> or <https://baanknet.com> which will provide account details) in bidders Global EMD wallet account. Bidders, not depositing the required EMD online, will not be allowed to participate in the e-auction. Bids without EMD shall be rejected summarily.
