M/s Abhilash Motocorp LLP availed Cash Credit facility from Indian Bank, Duliajan Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Abhilash Motocorp LLP failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 14/05/2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower M/s Abhilash Motocorp LLP; To the estate of the deceased Late Lachit Borah (Deceased on 20/08/2021) represented by Legal heirs viz. (1) Smt Banti Borah (2) Sri Abhilash Borah (Partner Cum Guarantor cum Mortgagor); Sri Abhilash Borah S/O Late Lachit Borah (Partner Cum Guarantor) and Smt Banti Borah W/O Late Lachit Borah (Guarantor) liable to the Bank to pay the amount due to the tune of **Rs.2,53,06,109/- (Rupees Two Crore Fifty Three Lakh Six Thousand One Hundred and Nine Only)** as on 14/05/2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 14/05/2024.

As M/s Abhilash Motocorp LLP failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 22/10/2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2), 8(6) & 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

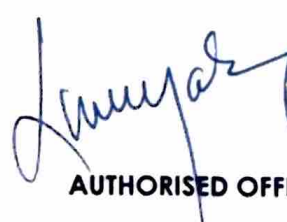
