Mrs. Madani Devi Teli W/o Ladu Lal Teli and Mr. Kanheiya Lal Teli S/o Shri Ladu Lal Teli has availed Loan facility from Indian Bank, **Bhilwara Main Branch** and the repayment of which is secured by Mortgage of schedule mentioned property hereinafter referred to as “the Property”.

Mrs. Madani Devi Teli W/o Ladu Lal Teli and Mr. Kanheiya Lal Teli S/o Shri Ladu Lal Teli failed to pay the outstanding dues to the Bank. Therefore, a **Demand Notice dated 28.10.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon **Mrs. Madani Devi Teli W/o Ladu Lal Teli and Mr. Kanheiya Lal Teli S/o Shri Ladu Lal Teli** liable to the Bank to pay the amount due to the tune of **₹ 11,77,336.00 (Rupees Eleven Lakh Seventy-Seven Thousand Three Hundred Thirty-Six Only) as on 27.10.2025** plus further Interest along with charges and expenses thereon **from 28.10.2025**. You failed to make payment despite **Demand Notice dated 28.10.2025**

As **Mrs. Madani Devi Teli W/o Ladu Lal Teli and Mr. Kanheiya Lal Teli S/o Shri Ladu Lal Teli** failed to make payment despite Demand Notice, the Authorized Officer took **symbolic possession** of the schedule mentioned properties under the Act on **04.02.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE E-AUCTION MODE.

As per **Rule 8(6)** read with **Rule 9(1)** of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days' notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on **27.10.2025** is **₹ 11,77,336.00 (Rupees Eleven Lakh Seventy-Seven Thousand Three Hundred Thirty-Six Only)** plus further Interest along with charges and expenses thereon from **28.10.2025**.

Please take note that this is notice of **30** days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **30** days.

The date of sale is fixed as 27.07.2026 which would be by E-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **25.06.2026 to 26.07.2026** between **11.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/Purchasers are requested to register with online portal (<https://baanknet.com>) (PSB Alliance Pvt. Ltd.) using their mobile number and email id.
