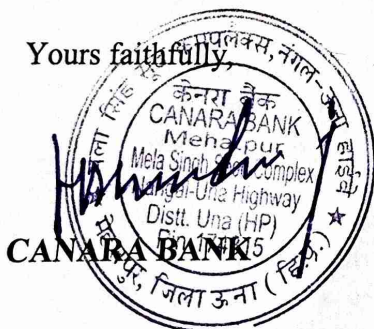

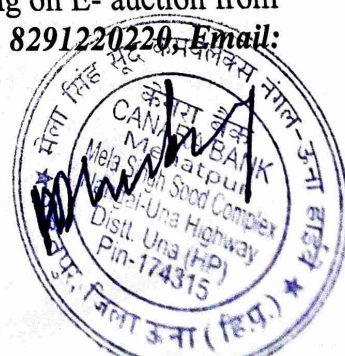
OTHER TERMS AND CONDITIONS
