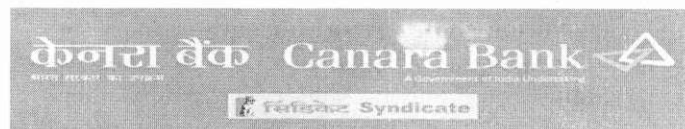

Other terms and conditions:

- a. The vehicle/s will be sold in “As is where is”, “As is what is”, and “Whatever there is” (The possession of the vehicle already lies with the bank), including encumbrances if any (There are no encumbrances to the knowledge of the Bank).
 - b. Auction/bidding shall be only through “Online Electronic Bidding” through the website: <https://Baanknet.in/> Bidders are advised to go through the website for detailed terms before taking part in the e-auction sale proceedings.
 - c. The vehicle/s can be inspected on any working day during office hours.
 - d. The vehicle/s will not be sold below the Reserve Price and the participating bidders may improve their offer further during auction process.
 - e. EMD amount of 10% of the Reserve Price is to be deposited deposited in E-Wallet of M/s PSB Alliance Private Limited (E-bkay) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan on or before **13.07.2026 up to 5.00 p.m.**
- i.) After payment of the EMD amount, the intending bidders should submit a copy of the following documents/details on or before **13.07.2026** up to 5:00 PM, to **Canara Bank, KANKHAL**, by hand or by email.
 - ii.) Demand Draft/Pay order towards EMD amount. If paid through RTGS/NEFT, Acknowledgement receipt thereof with UTR No.
Photocopies of PAN Card, ID Proof and Address proof. However, successful bidder would have to produce these documents in original to the Bank at the time of making payment of balance amount of 25% of bid amount.

 - b. EMD deposited by the unsuccessful bidder shall be refunded to them. The EMD shall not carry any interest.
 - c. Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of **Rs. 5,000/-** (The amount can be decided by the authorised officer depending upon the value of the vehicle/s with a minimum of **Rs. 5,000/-** as incremental value). The bidder who submits the highest bid (not below the Reserve price) on closure of 'Online' auction shall be declared as successful bidder. Sale shall be confirmed in favour of the successful bidder, subject to confirmation of the same by the secured creditor.
 - d. The successful bidder shall deposit 25% of the sale price (inclusive of EMD already paid), immediately on declaring him/her as the successful bidder and the balance within 15 days from the date of confirmation of sale by the secured creditor. If the successful bidder fails to pay the sale price within the period stated above, the deposit made by him shall be forfeited by the Authorised Officer without any notice and vehicle/s shall forth with be put up for sale again.
 - e. All charges for conveyance, taxes, transfer of ownership and registration charges etc., as applicable shall be borne by the successful bidder only.
