TERMS AND CONDITIONS

The sale shall be subject to the Terms & Conditions prescribed in the Security Interest (Enforcement) Rules 2002 and to the following further conditions:

1. The auction sale will be "online through e-auction" portal <http://www.baanknet.com> on **17.07.2026 @ 11.00 AM to 4.00 PM**
2. The intending Bidders/ Purchasers are requested to register on portal (<https://www.baanknet.com>) by using their mobile number and email-id. Further, they are requested to do "Buyer registration" through Digi-locker. The intending Bidders/ Purchasers then have to credit amount in his E-Wallet through online or by Chalan (ebkay site generated) through bank.
3. The intending Bidders/ Purchasers are requested participate by transferring EMD amount from e-wallet before EMD end date and time as mentioned in the www.baanknet.com.
4. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through 3 mode i.e. NEFT/ Cash/ Transfer (After generation of Challan from (<https://www.baanknet.com>) in bidders E-Wallet. NEFT transfer can be done from any Scheduled Commercial Bank, however for Cash/ Transfer the bidder has to visit Punjab National Bank Branch.
