Sub: Your HL Account No. 6201151936 for Rs. 20,00,000/-, HL Plus Account No 6847040583 for Rs. 18,00,000/-, Salary Loan Account No. 6491084624 for Rs. 5,00,000/-, with Indian Bank Kadayanallur Branch.

Mr. S D Cherman and Mrs Kalaiselvi availed Home Loan, Home Loan plus and salary loan facility from Indian Bank, Kadayanallur Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. S D Cherman and Mrs Kalaiselvi failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated 10.01.2024 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon borrowers Mr. S D Chairman and Mrs. Kalaiselvi liable to the Bank to pay the amount due to the tune of **Rs.46,66,326.00/- (Rs. Forty-Six Lakh Sixty-Six Thousand Three Hundred and Twenty-Six rupees only)** as on 09.01.2024 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 10.01.2024.

As Mr. S D Cherman and Mrs Kalaiselvi have failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 12.03.2024 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on 19.06.2026 is **Rs.66,56,625/- (Rupees Sixty-Six Lakhs Fifty-Six Thousand and Six Hundred and Twenty-Five Only)** with further interest, costs, other charges and expenses thereon from 20.06.2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 08.07.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from **25.06.2026** to **07.07.2026** between **10.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com>) (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by 07.07.2026 @ 5.00 PM i.e before the e-Auction Date and time in the portal. The registration, eKYC and transfer of EMD in wallet must be completed well in advance, before auction.
