Rupee surges 77 paise to settle at 95.08 vs USD

MUMBAI, June 12 (PTI)

THE rupee surged 77 paise to close at 95.08 (provisional) against the greenback on Friday as global oil prices fell sharply after US President Donald Trump indicated an imminent deal with Iran. A firm trend in domestic equity markets and a weaker American currency also supported the rupee during the day, forex traders said.

Trump has said a deal to end the war with Iran is nearly complete, and is expected to be signed over the weekend in Europe, as he called off military strikes on the Islamic Republic hours after threatening to take control of its oil industry. Following Trump's remarks, international crude oil prices fell with Brent crude -- the global oil benchmark -- trading lower by 4.25 per cent at USD 86.54 per barrel in futures trade. At the interbank foreign exchange, the rupee opened at 95.40 and traded in the range of 94.95-95.53 before settling at 95.08 (provisional), up 77 paise from its previous close.

Gold rebounds Rs 3,000; silver rallies Rs 10,000

NEW DELHI, June 12 (PTI)

GOLD prices rebounded by Rs 3,000 to Rs 1.56 lakh per 10 grams in the national capital on Friday, and silver advanced by Rs 10,000 to Rs 2.55 lakh per kilogram as signs of a diplomatic breakthrough in the US-Iran standoff rekindled interest in the precious metals.

According to local marketmen, the yellow metal of 99.9 per cent purity climbed by Rs 3,000 to Rs 1,56,900 per 10 grams (inclusive of all taxes) from Thursday's closing level of Rs 1,53,900 per 10 grams. Silver also recovered sharply, surging Rs 10,000 to Rs 2,55,700 per kilogram (inclusive of all taxes). The white metal had settled at Rs 2,45,700 per kg in the previous session.

"Gold prices rebounded sharply on Friday as growing optimism surrounding a potential US-Iran peace agreement improved sentiment across the precious metals market," Saumil Gandhi, Senior Analyst - Commodities at HDFC Securities, said.

TCS launches India's first Oracle AI Data platform lab in Kolkata

TATA Consultancy Services on Friday launched India's first Oracle AI Data Platform Lab and Centre of Excellence (CoE) here to help enterprises accelerate adoption of artificial intelligence and data-driven transformation.

The facility at Delta Park Lords in Kolkata has been set up in collaboration with Oracle and will support customers in addressing challenges such as fragmented data systems, slow analytics cycles, limited AI scalability and operational inefficiencies, the IT major said.

TCS said the lab will leverage Oracle AI Data Platform, which combines Oracle Cloud Infrastructure, Oracle Autonomous AI Database and OCI Enterprise AI, to help organisations make enterprise data AI-ready and deploy AI-powered applications and automation at scale. The IT services major also plans to establish similar Oracle AI Data Platform Labs and

India leads in PMI among top 10 economies despite West Asia crisis, says Assocham

NEW DELHI, June 12 (IANS)

INDIA'S Purchasing Managers' Index (PMI) has shown strong resilience despite the winds of war in West Asia and rising energy input prices, according to an Assocham report on Friday.

The PMI for India in May stands at 59.3, significantly higher than in all the major top 10 economies, with China at 54, the US at 51.5, Japan at 51.1 and Italy at 50.4. From January to May 2026, India's PMI maintained a steady expansion despite global economic turbulence, according to Assocham Global Research. "India's consistency in these fundamentals is largely driven by the structural strength of domestic demand, rising income levels, an aspirational middle class and a conducive business environment," said Nirmal K Minda, President, Assocham.

India's PMI performance since the West Asia conflict began in February 2026 has shown a



steady trajectory. The PMI rose to 59.3 in May 2026, compared with 58.9 in February 2026.

The Purchasing Managers' Index (PMI) is the most direct measure of the country's economic health. It ranges from 0 to 100, with values above 50 indicating expansion and those below 50 indicating contraction.

No other country in the top 10 economies has recorded posi-

tive growth in its PMI; instead, they have decelerated from their February PMI to their May PMI, including Germany, France, Japan and the UK. Even the largest economy, the USA, and the second-largest economy, China, also recorded a fall of 0.4 in their respective PMIs from February 2026 to May 2026.

France recorded the highest fall in the PMI, from 49.9 in February 2026 to 44.9 in May

2026. India's growth performance during the West Asia conflict months from February to May remained strong and steady as our exports grew by 13.59 per cent in April 2026 and growth projections also remain intact.

The World Bank has projected India's growth at 6.6 per cent for the year 2026-27, though global growth is projected to decelerate to 2.5 per cent in 2026.

Tata Motors to hike prices of cars, SUVs by up to 1.5 pc from July 1

NEW DELHI, June 12 (PTI)

TATA Motors Passenger Vehicles Ltd on Friday said it will increase prices of its passenger vehicle portfolio, including both internal combustion engine (ICE) and electric vehicles (EVs) by up to 1.5 per cent from July 1, marking its second hike in three months after the company raised prices of its ICE vehicle range from April 1, amid escalating cost pressures due to the ongoing West Asia conflict-led disruptions. The automaker had previously hiked prices of its internal combustion engine (ICE) passenger vehicles from April 1, 2026. "This price revision is being undertaken to partially offset the impact of rising input costs and sustained inflationary pressures," the company said in a regulatory filing.

While Tata Motors Passenger Vehicles continues to absorb a significant portion of these increases, a part of the impact is being passed on to customers through this adjustment, Tata Motors Passenger Vehicles stated. "The extent of the price increase will vary

across models and variants, ensuring that the overall value proposition of each is maintained," it added.

Car market leader Maruti Suzuki India earlier hiked prices of its vehicles across models by up to Rs 30,000 from June 1, citing inflationary pressures and an adverse cost environment.

Hyundai Motor India Ltd also increased prices of its vehicles by up to Rs 12,800 from June 1, depending on the model and variants.
