Mr. Swapan Bera, Represented by legal heir Reported Deceased as on 24/03/2025) & Mrs. Sudipa Dolal D/o-SwapanBera (In the estate of the deceased Lt. Mr. Swapan Bera, Represented by legal heir Reported Deceased as on 24/03/2025) failed to make payment despite Demand Notice; the Authorised Officer took possession of the schedule mentioned properties under the Act on 22.01.2026 after complying with all legal formalities.

As per Rule 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 09.10.2025 is Rs.22,79,178/- (**Rupees Twenty Two Lakh Seventy Nine Thousand One Hundred Seventy Eight only**) with further interest, costs, other charges and expenses thereon till the date of payment.

Please take note that this is notice of **30 days** and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after **30 days**.

The date of sale is fixed as 07.08.2026 which would be by e-auction mode.
