M/s Srikrishna Pharmacy Proprietor Mr. HIRAK HAZRA availed financial facility from Indian Bank, Atghara Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Srikrishna Pharmacy, Mr. HIRAK HAZRA proprietor & Mrs. Minatirani Hazra failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 03.12.2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s) M/s Srikrishna Pharmacy, Mr. HIRAK HAZRA proprietor & Mrs. Minatirani Hazra liable to the Bank to pay the amount due to the tune of Rs.3168142.00 (Rupees Thirty one lakh sixty eight thousand one hundred and forty two only) as on 03.12.2025 and carries further interest at the agreed rate, charges and expenses thereon till the date of payment. Both failed to make payment despite Demand Notice dated 03.12.2025.

As M/s Srikrishna Pharmacy, Mr. HIRAK HAZRA proprietor & Mrs. Minatirani Hazra failed to make payment despite Demand Notice; the Authorised Officer took possession of the schedule mentioned properties under the Act on 17.02.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 03.12.2025 is Rs.3168142.00 (Rupees Thirty one lakh sixty eight thousand one hundred and forty two only) with further interest, costs, other charges and expenses thereon till the date of payment.
