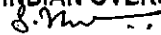

1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com.psb/bidder-registration> under the supervision of the Authorized Officer of the Bank.

2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com.psb/bidder-registration> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents.
