1. This has reference to recovery actions initiated against you under the provisions of the SARFAESI Act 2002.

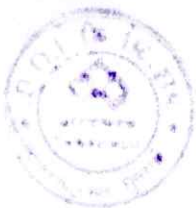

E-auction notice containing terms and conditions

1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com.psb/bidder-registration> under the supervision of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com.psb/bidder-registration> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 1 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **23.07.2026 before 09.00 a.m.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3.
