

E-AUCTION OF RESIDENTIAL SITES

At Rs 18.8 crore, 500-square-yard plot in Sec 21 secures top bid

A 500-SQUARE-YARD residential site in Chandigarh's Sector 21 emerged as the top draw at the UT Estate Office's e-auction on Monday, fetching Rs 18.88 crore against a reserve price of Rs 16.52 crore, while a 250-square-yard plot in Sector 15-B was sold for Rs 8.33 crore, slightly above its reserve price of Rs 8.23 crore.

Of the 10 residential freehold sites put up for auction, only these two found buyers, with the combined bids touching Rs 27.21 crore.

The UT Estate Office's e-auction of residential freehold sites witnessed a muted response on Monday, with only two of the 10 properties on offer attracting successful bids. The remaining sites will be put up for re-auction now, around Rs 2.45 crore higher than the combined reserve price of the two properties that were sold.

The highest bid came for a 500-square-yard residential site in Sector 21, which was auctioned for Rs 18.88 crore against its reserve price of Rs 16.52

crore, fetching 14.25 per cent above the reserve price.

The second successful bid was for a 250-square-yard residential site in Sector 15-B, which was sold for Rs 8.33 crore, marginally above its reserve price of Rs 8.23 crore, reflecting an increase of about 1.21 per cent.

According to the Estate Office, the e-auction was conducted through its online portal. Officials said the unsold residential sites would be re-auctioned shortly, giving prospective buyers another opportunity to participate.

While the Sector 21 site witnessed strong competition with a premium of over 14 per cent above the reserve price, the Sector 15-B plot was sold at a marginal premium of 1.21 per cent.

Despite 10 residential freehold sites being put up for e-auction, bids were received for only two properties. Estate Office officials said the remaining eight unsold sites would be offered again in a fresh round of e-auction, giving interested buyers another opportunity to participate.

Football Players Association of Punjab signs MoU to give fillip to grassroots

LAST YEAR, when former India defender and coach Anwar Ali Sr. spoke to his former teammates and current Indian footballers from Punjab about forming a body for footballers from the state, most responded positively.

Ali, who represented India in 33 international matches between 2008 and 2019, had launched the Football Players Association of Punjab (FPAP) under the aegis of the Football Players Association of India last year. As the association signed a Memorandum of Understanding (MoU) with the Roundglass Foundation on Monday, Ali explained the vision behind the initiative.

"When a player represents Punjab, India or clubs during his career, he hardly gets time to spend in Punjab or work at the grassroots level. The football calendar keeps players busy across leagues and countries, leaving little opportunity to give back to the game. Many of us also faced several challenges on our journey to the Indian team. That is how the idea of forming the Football Players Association of Punjab came about," Ali told *The Indian Express*. "States such as Sikkim and Jammu & Kashmir had similar player associations, but they could not sustain themselves. Through this initiative, we want to contribute to the growth of football in Punjab," he added.

A native of Kurka Kalan near Phagwara, Ali played in the Santosh Trophy final in 2004 before being named the Most Promising Footballer at the Durand Cup during the 2006-07 season while representing JCT. He made his India debut at the 2008 SAFF

Cup and was part of the squad that won the 2009 Nehru Cup.

While Punjab has consistently produced footballers from regions such as Mahilpur, Jalandhar and Gurdaspur, Ali believes the state has witnessed a decline in producing players who progress to the national team and the Indian Super League (ISL).

"Players such as Jarnail Singh Dhillon, who represented India at the 1960 Rome Olympics and won gold at the 1962 Asian Games in Jakarta, along with Inder Singh and Gurdev Singh Gill, were the pride of Punjab football. Many Punjab players represented India after that era, but the state has witnessed a gap in producing top talent over the last 10 to 15 years," he said.

"When the ISL started, over 30 Punjab players featured

across eight teams. Today, despite the league expanding to 14 teams, the number of Punjab footballers has come down to around 15. Punjab has many licensed coaches, but what we lack is a proper football structure and strong junior development programmes. Countries like Japan have benefited immensely from investing in youth development alongside quality coaching. India can follow the same path. Through FPAP, we aim to organise coaching workshops and development programmes for young footballers," Ali added.

India goalkeeper and Odisha FC captain Amrinder Singh was also present during the signing of the MoU. The 34-year-old, who has represented India in 14 international matches and was part of Odisha FC's Super Cup-winning squad in 2023, said

such an association would have been invaluable during his early years.

"Before reaching the senior level, young players need guidance from experienced internationals about the challenges they are likely to face. When we were growing up, there were very few senior footballers we could approach for advice. We want to bridge that gap," said Singh.

Gokulam Kerala FC striker Harmilan Kaur, another member of FPAP, highlighted the challenges faced by women footballers.

"Most women footballers have limited opportunities beyond district and state-level competitions. Greater participation will only come when young talent is nurtured and more playing opportunities are created," she said.

Rent deal with 'CISF officer' costs Panchkula man Rs 14L; cyber trail ends in Rajasthan arrests

WHAT BEGAN as an online search for a tenant turned into a Rs 14.13-lakh cyber fraud after scammers posing as a CISF officer convinced a Panchkula resident to transfer money instead of receiving rent and a security deposit.

Nearly three years after the fraud, the Panchkula Cyber Crime Police have arrested two more accused from Rajasthan, taking the total number of arrests in the case to four.

The arrested accused have been identified as Vikram Singh Bhandari, a resident of Bharatpur, and Dilkush Meena of Dausa district, Rajasthan. Both were produced before a court and remanded to judicial custody.

Two other accused from Rewa in Madhya Pradesh had already been arrested in 2023.

According to the police, the complainant had advertised his Delhi house for rent online when he was contacted by a person claiming to be a CISF officer. On the pretext of transferring the rent and security deposit, the fraudsters manipulated the victim into transferring Rs 14.13 lakh to multiple bank accounts instead of receiving payment.

The case was registered in

May 2023, and investigators later uncovered a wider cyber fraud network. During the investigation, police found that Rs 8.40 lakh had been routed through Vikram Singh Bhandari's bank account, which he had allegedly provided for use in cyber fraud. He was arrested in Rajasthan on June 24.

During interrogation, Bhandari allegedly disclosed the involvement of co-accused Dilkush Meena, who was arrested on June 28.

Earlier, police had arrested Ayush Kumar Mishra and Piyush Kumar Tripathi, both residents of Rewa, Madhya Pradesh. Investigators had also recovered part of the cheated amount and several ATM cards allegedly used in the commission of the crime.

The investigation, being conducted by Sub-Inspector Jagmeet Singh, is underway to identify and arrest other members of the racket.

Panchkula DCP (Crime and Traffic) Amarinder Singh said the police would continue pursuing cyber criminals irrespective of how old a case is. He urged citizens to remain cautious while renting out property online and advised them never to transfer money, scan QR codes or follow payment instructions shared by unknown persons claiming to send rent or advance payments.

SIR enumeration drive gains momentum in Mohali; voters urged to submit forms on time

THE SPECIAL Intensive Revision (SIR)-2026 of electoral rolls is gathering momentum across Mohali district, with Booth Level Officers (BLOs) intensifying distribution and collection of enumeration forms to ensure every eligible voter is covered.

According to the Mohali administration, 2.99 lakh enumeration forms have been received since June 25.

As part of the drive, BLOs are conducting door-to-door visits and setting up facilitation camps at polling stations to help voters fill and submit their enumeration forms within the stipulated time.

The district election authorities have urged residents to cooperate with the exercise and submit forms to their respective BLOs without delay to ensure the electoral rolls remain accurate and comprehensive.

District Nodal Officer (SVEEP) Prof Gurbakshish

Singh Antal also participated in the campaign and assisted voters in filling out their enumeration forms and spread awareness about the importance of the SIR process.

Election Kanungos Varun Kumar and Jagtar Singh were also associated with the awareness and facilitation drive.

Additional Deputy Commissioner (General)-cum-Additional District Election Officer Geetika Singh visited several polling stations across the district to review the progress of the ongoing exercise.

She reviewed the work at Booth Nos. 242 and 255 in Sector 70, Booth Nos. 133, 232, 233, 234 and 235 in Mataur, besides polling stations in Sectors 78 and 79.

She interacted with BLOs and directed them to ensure no eligible voter is left out of the enumeration process. She instructed BLOs to complete the distribution and collection of enumeration forms within the prescribed timeline with dedication and responsibility.
