The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction.

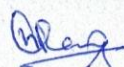
- successive higher bid and if no higher bid is offered by any bidder after the expiry of ten minutes to the last highest bid, the e-auction shall be closed.
