

Lucknow, June 5: The Uttar Pradesh Sangeet Natak Akademi has preserved more than 5,500 hours of rare audio-video recordings documenting the state's folk music and theatre traditions, Governor Anandiben Patel said Friday.

Addressing the Akademi Samman Samaroh-2026 at the Jan Bhavan's Gandhi Auditorium here, Deputy Chief Minister Brajesh Pathak read out the governor's message, in which she congratulated the award-winning artistes and emphasised that culture is not merely a legacy but al-

The event was organised by the Uttar Pradesh Sangeet Natak Akademi, where 51 eminent artistes selected for 2021, 2022, 2023 and 2024 were honoured for their outstanding contribution to music, dance, theatre and folk arts.

In her message, Patel said art is not only a medium of entertainment but also a powerful tool for the moral, cultural and spiritual development of the society.

"Art is a heritage of the past as well as an inspiration for the future. It guides the society for generations," she said.



The governor said artistes are custodians of cultural traditions whose dedication has kept India's artistic heritage alive.

Referring to folk traditions, she said folk songs and theatre are essential to understanding the soul of civilisation as they carry identity and traditions across generations.
