The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs 60,000/-** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details A/c no 209272434 IFSC Code **CNRB0005131** on or before **19.07.2026** before 5.00 pm.
6. Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of **Rs. 5,000/-** (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1).
