M/S KMR Sales Corporation Proprietor Mr.Shaphath K N have availed loan facility from Indian Bank, Irinjalakuda Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/S KMR Sales Corporation Proprietor Mr.Shaphath K N and Mrs.Samsam C M** failed to pay the outstanding dues to the Bank. Therefore a **Demand Notice dated 17.12.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon **M/S KMR Sales Corporation Proprietor Mr.Shaphath K N and Mrs.Samsam C M** liable to the Bank to pay the amount due to the tune **Rs.99,86,272/- (Rupees Ninety nine lakhs eighty six thousand two hundred seventy two only)** as on **17.12.2025** with further interest, costs, other charges and expenses thereon. As **M/S KMR Sales Corporation Proprietor Mr.Shaphath K N** and **Mrs.Samsam C M** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **09.03.2026** after complying with all legal formalities.
