M/s C P Sponge Iron Private Limited availed OCC facility from Indian Bank, SME Finance Branch Kolkata, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s C P Sponge Iron Private Limited failed to pay the outstanding dues to the Bank. All failed to make payment despite Demand Notice dated 29.10.2026.

As M/s C P Sponge Iron Private Limited, Mr. Shyam Bihari Makharia, Mr. Govind Ram Sharma, Mr. Manoharlal Chawla, Mr. Kumar Chand Chawla, Mr. Mohan Chawla, Mr. Dilip Chawla, Mr. Amarjeet Chawla, Mr. Amit Chawla, Mr. Naresh Kumar Sharma, M/s Jaishree Steel Pvt Ltd, M/s Sova Electrocasting Ltd, M/s Savitri Ispat India failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 20.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 29.10.2026 is **Rs. 23,78,51,711/- (Rupees Twenty-Three Crores Seventy-Eight Lakhs Fifty-One Thousand Seven Hundred and Eleven only)** with further interest, costs, other charges and expenses thereon from 30.10.2026.



Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 12.08.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc by the intending purchasers/bidders may be done at their expense from 15.07.2026 to 11.08.2026 between **10.00 am to 4.00 pm.**
