Terms and conditions of E-auction

1. The property(ies) will be sold by e-auction through the service provider www.iob.in & <https://ebkcray.com> under the supervision of the of the Authorized Officer of the Bank.

2. The intending Bidders /Purchasers are requested to register on portal www.iob.in & <https://BAANKNET.com> using their mobile number and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account by **23.07.2026** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (**After generation of Challan from www.iob.in & <https://ebkcray.com>, which will provide account details**) in bidders Global EMD Wallet account.
