bank as on the date of taking possession was intimated **Rs.89,65,811.69 (Rupees Eighty Nine Lakhs Sixty Five Thousand Eight hundred and Eleven and sixty nine paise only)** payable together with further interest at contractual rates and rests along with costs, charges etc. till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **31.05.2026** works out to is **Rs. 93,78,988.69 (Rupees Ninety Three Lakhs Seventy eight Thousand Nine Hundred and eighty eight rupees and sixty nine Paisa Only) plus unrecognised interest, charges etc.** after reckoning repayments, if any, subsequent to the Bank issuing demand notice.

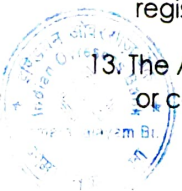

Terms and Conditions

1. The property(ies) will be sold by e-auction through the service provider <https://baanknet.com/eauction-psb/bidder-registration> under the supervision of the Authorized Officer of the Bank.
2. The intending Bidders /Purchasers are requested to register on portal <https://baanknet.com/eauction-psb/bidder-registration> using their mobile number

and email-id. Further, they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his Global EMD Wallet account **before the commencement of E-Auction**. Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3. The EMD and other deposits shall be remitted through EFT / NEFT / RTGS to the Bank account as specified above and the amount of EMD paid by the interested bidder shall carry no interest. The amount of EMD paid by the successful bidder shall be adjusted towards the sale price. Bids without EMD shall be rejected summarily.

6. Bidder's Global Wallet should have sufficient balance ($\geq$ EMD amount) at the time of bidding.
7. Online auction sale will start automatically on and at the time as mentioned above. Auction / bidding will initially be for a period of **120 Minutes** with auto extension time of **10 minutes** each till the sale is concluded.
8.
