Madhya Pradesh govt launches 24-hour renewable energy project:

Bhopal: Madhya Pradesh Chief Minister Dr Mohan Yadav said on Wednesday that his government has launched an ambitious project to provide round-the-clock renewable energy, marking the beginning of a new chapter in the state's clean energy journey. He said that, in line with the commitment made at Davos, Madhya Pradesh is moving rapidly towards ensuring the availability of 24-hour green energy. Dr Yadav was virtually addressing the pre-bid meeting for the 24-hour Renewable Energy Project held at Madhya Pradesh Bhavan in New Delhi, from the Chief Minister's Residence 'Samatva Bhavan' at Bhopal. The Chief Minister said that the Rewa Ultra Mega Solar Project achieved the country's lowest solar tariff and brought global recognition to India. He said that Shajapur and Neemuch Solar Parks recorded the state's lowest tariff at ₹2.14 per unit. He further said that the recently signed Power Purchase Agreement (PPA) for the four-hour storage-plus project in Morena, at a tariff of ₹2.70 per unit, is among the most competitive energy storage projects in the country.
