Whereas the undersigned being the Authorized Officer of the Bank of Baroda u/s 13(2) of the above said SARFAESI Act, 2002 and in exercise of the powers conferred u/s 13(2) of the said Act read with Rule 3 issued a Demand Notice on **10.04.2024** calling upon the Borrower(s)- **Mr. Ramdas Chadar S/O Gorelal Chadar and Mrs. Savita Chadar WO Ramdas Chadar and Guarantor(s)** to repay the amount in terms of the said notice within 60 days from the date of the said notice.
