- (1) The e-Auction is being held on "AS IS WHERE IS" and "AS IS WHAT IS" and "WHATEVER THERE IS" basis. The intending bidders should make their own discreet independent inquiries & verify the concerned Registrar/SRO/Revenue Records/other Statutory Authorities regarding the encumbrances and claims/rights/dues/charges of any authority such as Sales Tax,

- (2) The sale will be done by the undersigned through e-auction platform provided at the Website <https://baanknet.com> on 09.07.2026 (2.00 PM to 4.00 PM). The intending bidders/purchasers are requested to register on portal <https://baanknet.com> using their mobile number and email-id. Further they are requested to upload requisite KYC documents. Once the KYC documents are verified by e-auction service provider(may take 2 working days), the intending Bidders/Purchasers has to transfer the EMD amount using mode in his Global EMD Wallet well in advance before the auction time. In case EMD amount is not available in Global EMD Wallet, system will not allow to bid. The registration, verification of KYC documents and transfer of EMD in wallet must be completed well in advance, before auction. Only after having sufficient EMD in his wallet, the interested bidder will be able to bid on the date of e-auction. Bidders Global Wallet should have sufficient balance (>EMD amount) at the time of bidding.

The bidder shall improve their offer as specified in publication notice, which will be the bid Increase Amount. The property will not be sold below the Reserve Price set by the Authorized officer. - (9) The successful bidder shall have to deposit 25% (Twenty five per cent) of the bid amount, less EMD amount deposited through NEFT/RTGS in **a/c-3810385432, IFSC –CBIN0280381**, on the same day or not later than next working day and the remaining amount shall be paid within 15 days from the date of confirmation of sale. In case of failure to deposit the amounts as above within the stipulated time, the amount deposited by successful bidder will be forfeited to the Bank and Authorized Officer shall have the liberty to conduct a fresh auction/sale of the property, default of payment shall render automatic cancellation of sale without any notice & the defaulting bidder shall not have any claim over the Forfeited amount and the property.

The purchaser shall bear the Stamp duties, including those of Sale Certificate, Registration Charges, all statutory dues payable to Government Authority, Taxes, GST and rates and outgoing both existing and future relating to properties.
- (12) No request for inclusion/substitution of names, other than those mentioned in the Bid, in the Sale Certificate will be entertained. The Sale Certificate will be issued only in the name of successful bidder.
- (13) The Sale Certificate will not be issued till any pending operation of any Stay/Injection/Restraint Order passed by the DRT/DRAT/High Court or any other court against the issue of Sale Certificate. Further no interest will be paid on the amount deposited during this period. The deposit made by the successful bidder, pending execution of Sale Certificate, will be kept in non-interest bearing deposit account. No request for return of deposit either in part or full/cancellation of sale will be entertained.
