

Helpline helps police check drug trafficking in Kosi region: Official

SAHARSA: The Kosi division police comprising three districts, Saharsa, Madhepura and Supaul, have arrested 1,223 smugglers between February and mid June and seized thousands of litres of illegal alcohol besides other narcotics. The drive is part of an ongoing crackdown on drug abuse and illegal liquor, deputy inspector general (DIG) of police, Kosi range Dr Kumar Ashish said.

Declaring it a very good achievement, DIG said, "The drive launched by the police has yielded good results," adding "In this campaign; police have got overwhelming support from the common people who have provided invaluable inputs about drug peddlers."

He said, "People in large numbers have come forward to help police through the helpline number (9060384865) in the 'Nasha Mukti Kosi' campaign."

"The identity of the informers is kept confidential," DIG said adding "Whatever information we get through this helpline number, we take prompt action." Expressing happiness, he said people's inputs and intelligence of police have worked wonders in the campaign.

Between February and June (13) about 39.40 quintals ganja (marijuana), 37.34 kg smack (heroin), 1,805 litres banned cough syrup, 3,256 ML intoxicant injections, over 120 intoxicant pills besides 43,972 litres illegal alcohol have been seized and 1,223 drug traffickers were arrested.

and drug control have been quite challenging for security agencies along the Indo-Nepal border districts. "Ensuring robust border security and eliminating the nexus of smuggling and narcotics is our top priority," DIG said adding "We hold regular meetings with Sashatra Seema Bal (SSB) and work in close coordination to achieve tangible results on the ground."

Besides, he stressed the need for launching a consistent awareness campaign especially among youths and children against drug smuggling and drug abuse in rural as well as urban areas especially in schools.

The police believe that tracking such cases will help them study the operating patterns of drug peddlers and identify areas where narcotics are being supplied or distributed.

"The majority of the cases involve marijuana and smack (heroin) consumption while a large number of people still consume alcohol," a police officer told HT.

Social activist Amit Anand expressed deep concern over children fast falling in the grip of drugs. "We all must stand and fight against the drug menace to protect our future generation," he said, declaring DIG's initiative a noble step exhorting the people to work in tandem with police in the campaign to make Kosi 'drug free region.'

Promote plastic-free practices in hospitals and clinics: IMA

PATNA: The Bihar state branch of the Indian Medical Association (IMA) has directed its local units across the state to promote plastic-free practices in hospitals, clinics, nursing homes, pharmacies and medical stores, citing growing environmental and public health con-

cerns arising from the use of single-use plastic bags.

In a circular issued on Saturday, IMA Bihar said medicines and healthcare-related items are frequently dispensed in single-use plastic bags, contributing significantly to environmental pollution and increasing pressure on waste management systems. The association also warned that plastic waste and

microplastics pose risks to ecosystems and human health.

The IMA headquarters has urged all state branches to take proactive measures to reduce plastic use in healthcare settings. Accordingly, IMA Bihar has asked its local branches to encourage healthcare institutions to gradually eliminate single-use plastic bags and adopt eco-friendly alternatives.

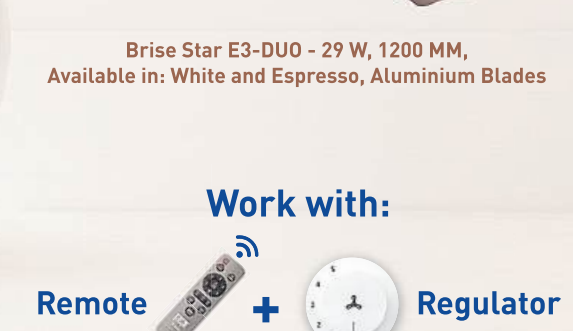
