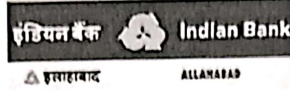

Sub: Your Agriculture Allied MTL – A/c 6294686907 with Radhapuram Branch.

Mrs. Bharathi K, (Borrower, Mortgagor & Legal heir of Mr Kathirvel) availed Bank AMTL (Ac No 6294686907) Loan facility from Indian Bank, Radhapuram Branch. The repayment of loan is secured by Mortgage of schedule mentioned properties. Mrs. Bharathi K failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **04.02.2026** under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s) and Guarantor(s), liable to the Bank to pay the amount dues to the tune of Rs. **5739527/- (Rupees Fifty seven lakhs thirty nine thousand five hundred and twenty seven only)** as on **04.02.2026** and the said amount carries further interest at the agreed rate, Charges, expenses from **04.02.2026** till date of repayment. Both failed to make payment despite Demand Notice dated **14.10.2024**.

As Mrs. Bharathi K, (Borrower, Mortgagor & Legal heir of Mr Kathirvel) failed to make payment despite Demand Notice, the Authorized Officer took possession of the

schedule mentioned properties under the Act on **11.05.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends to sell the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER / AUCTION ADOPTING THE e-AUCTION MODE.

As per Rule 6(2) and 8(6) and 9(1) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 03.06.2026 is **Rs.60,25,761/- (Rupees sixty Lakhs Twenty Twenty five Thousand seven Hundred and sixty One Only)** with further interest, costs, other charges and expenses thereon from 03/06/2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 08.07.2026 which would be by e-auction mode.

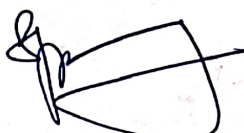
Inspection of the scheduled properties and related documents/up to date EC etc may be done by the intending purchasers/bidders at their expenses from **04/06/2026 to 07/07/2026 from 10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule.

The Tender/bid Form with the Terms and conditions can be had on-line from the website (<https://www.baanknet.com>) (PSB Alliance Pvt. Ltd.) and using the provision in the system/software. The tender form and the terms and conditions would be available in the website.

The successful bidder shall have to deposit 25% (twenty five percent) of the bid amount, including EMD amount (10%) deposited, latest by the next working day and the remaining amount shall be paid within 15 days from the date of auction in the form of Banker's Cheque/ Demand Draft /Account Transfer and/ or any other acceptable mode of money transfer. 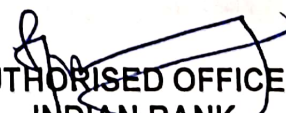
