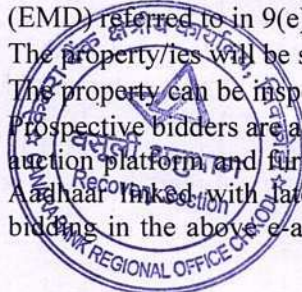

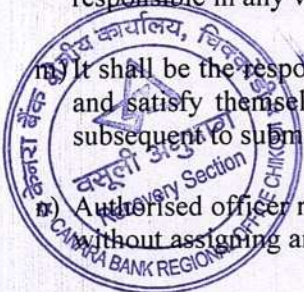

- e) The intending bidders shall deposit Earnest Money Deposit (EMD) of **Rs.1,25,000/- (Rupees One Lakh Twenty Five Thousand Only)** being of 10% of the Reserve Price in E-Wallet of M/s PSB Alliance Private Limited (BAANKNET) portal directly or by generating the Challan therein to deposit the EMD through RTGS/NEFT in the account details as mentioned in the said challan" on or **before 29.07.2026 at 5.00 PM.**
