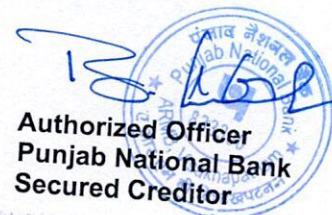
any time without assigning any reason whatsoever and his decision in this regard shall be final.
