M/s Adithya Trade links and others availed Cash Credit facility from Indian Bank, CHANDRA NAGAR, PALAKKAD Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Adithya Trade links and others failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 22.10.2021 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower (s), Guarantor(s) M/s Adithya Trade links and others liable to the Bank to pay the amount due to the tune of Rs. 47,13,930/- (Rupees Forty seven lakhs thirteen thousand nine hundred thirty Only) as on 22.10.2021 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 22.10.2021.

As M/s Adithya Trade links and others failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.01.2022 after complying with all legal formalities

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode.

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

The amount due as on 06-07-2026 is Rs.1,07,56,903/- (Rupees One crore seven lakhs fifty six thousand nine hundred three Only) with further interest, costs, other charges and expenses thereon from 07-07-2026.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.
