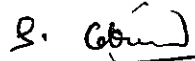

1. The property(ies) will be sold by e-auction through the service provider <https://BANANKNET.in/bidder-registration> under the supervision of the Authorized Officer of the Bank.

Further, they are requested to upload requisite KYC documents. 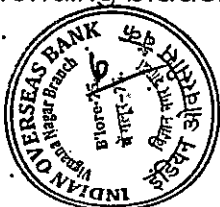

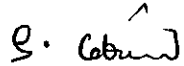
