The dues to the bank as on the date of taking possession was intimated as **Rs.10,76,19,692/- (Rupees Ten Crore Seventy Six Lakhs Nineteen Thousand Six Hundred Ninety Two only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

The dues of the borrower as on **02.07.2026** works out **Rs.12,79,87,970/14 (Rupees Twelve Crore Seventy Nine Lakhs Eighty Seven Thousand Nine Hundred Seventy and paise Fourteen Only)** after reckoning repayments, to **Rs.2,52,72,673/78 (Rupees Two Crore Fifty Two Lakhs Seventy Two Thousand Six Hundred and Seventy Three paise Seventy Eight Only)** subsequent to the Bank issuing demand notice.

Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers have to transfer the EMD amount using online mode in his **Global EMD Wallet account by 22.07.2026 at 5.00 P.M.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.

3.
