M/s Arabh Sanitary World (Prop: Mrs. Preeti Singh) failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated **12.09.2025** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as “The Act”), was issued by the Authorized Officer calling upon Borrower(s) and Guarantor(s) liable to the Bank to pay the amount due to the tune of **Rs. 9,36,322.00 + MOI+ MLE/MOX (Rupees Nine Lakh Thirty-Six Thousand Three Hundred Twenty-Two only + MOI + MLE/MOX)** with further interest, costs, other charges and

expense thereon. Both failed to make payment despite Demand Notice dated 12.09.2025

As M/s Arabh Sanitary World (Prop: Mrs. Preeti Singh) failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 17.01.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

The amount due as on 12.09.2025 is Rs. 9,36,322.00 + MOI+ MLE/MOX (Rupees Nine Lakh Thirty-Six Thousand Three Hundred Twenty-Two only + MOI + MLE/MOX) with further interest, costs, other charges and expenses thereon from 12.09.2025.
