Sale Notice is hereby given to the public in general and in particular to the Borrower (s) and Guarantor (s), that **M/s Yash Car Bazar Pvt Ltd** availed **Cash Credit** Loan facility from Indian Bank, **Indira nagar** Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **M/s Yash Car Bazar Pvt Ltd** failed to pay the outstanding dues to the Bank. Both failed to make payment despite Demand Notice dated 13.03.2026. As **M/s M/s Yash Car Bazar Pvt Ltd**(Borrower) failed to make payment despite Demand Notice, the Authorized Officer took physical /constructive / **Symbolic** (whichever is applicable) possession of the schedule mentioned properties under the Act on **30.05.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In
