Mr. Vicky Alani availed Home Loan facility from Indian Bank, Ambedkar Nagar Neemuch Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. Vicky Alani** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **11.02.2026** under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), **Mr. Vicky Alani** liable to the Bank to pay the amount due to the tune of **Rs. 20,16,389.375 (Rupees Twenty Lakhs Sixteen Thousand Three Hundred Eighty Nine Rupees and Three Hundred Seventy five Paise Only)** as on **11.02.2026** with further interest, costs, other charges and expenses thereon. Borrower failed to make payment despite Demand Notice dated **11.02.2026**.

As **Mr. Vicky Alani** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **05.05.2026** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In

accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **16.06.2026** is **Rs. 20,63,995/- (Rupees Twenty Lakhs Sixty Three Thousand Nine Hundred & Ninety Five Only)** with further interest, costs, other charges and expenses thereon from **17.06.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.07.2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **29.06.2026** to **24.07.2026** between **11.00 am to 4.00 pm**.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id.
