Mr. Vijay Khuraiya and Mr Raghunath Khuraiya_availed Home Loan and Home Plus facility from Indian Bank, Kalani Nagar Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". Mr. Vijay Khuraiya and Mr Raghunath Khuraiya failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 09.02.2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Mr. Vijay Khuraiya and Mr Raghunath Khuraiya, liable to the Bank to pay the amount due to the tune of Rs. 19,08,241/- (Rupees Nineteen Lakhs Eight Thousand Two Hundred Forty One Rupees Only) as on 08.02.2026 with further interest, costs, other charges and expenses thereon. Borrower failed to make payment despite Demand Notice dated 09.02.2026.

As Mr. Vijay Khuraiya and Mr Raghunath Khuraiya failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 14.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the

same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement)Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **18.06.2026** is **Rs. 19,70,668/- (Rupees Nineteen Lakhs Seventy Thousand Six Hundred & Sixty Eight Only)** with further interest, costs, other charges and expenses thereon from **19.06.2026**.

Please take note that this is notice of 15 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 15 days.

The date of sale is fixed as 27.07.2026 which would be by e-auction mode.

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule

The intending Bidders/ Purchasers are requested to register with online portal (<https://baanknet.com> (PSB Alliance Pvt. Ltd.) using their mobile number and email id. Further, after completing their eKYC, the intending Bidders/ Purchasers have to transfer the EMD amount in their e-Wallet by **27.07.2026** i.e the e-Auction Date and before the e-auction end time in the portal.
