M/s Shanu General Store availed a working capital facility from Indian Bank, Panwari Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Shanu General Store failed to pay the outstanding dues to the Bank. Therefore, a Demand Notice dated- 19/11/2025 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon –

Liable to the Bank to pay the amount due to the tune Rs. 5234308.00 (Rupees Fifty Two Lakhs Thirty Four Thousand Three Hundred And Eight only) as on 19/11/2025 with further



interest, costs, other charges and expenses thereon. M/s Shanu General Store failed to make payment despite Demand Notice dated 19/11/2025.

As M/s Shanu General Store failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 21.05.2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to affect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

THE SALE PROPOSED TO BE HELD IS BY WAY OF PUBLIC TENDER /AUCTION ADOPTING THE e-AUCTION MODE.

*As per Rule 6 (2) and 8(6) of The Security Interest (Enforcement) Rules 2002 framed under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, 30 days notice of intended sale is required to be given and hence we are issuing this notice.

The amount due as on 15/06/2026 is Rs.5726142.00 (Rupees Fifty Seven Lakhs Twenty Six Thousand One Hundred and Forty Two only) with further interest, costs, other charges and expenses thereon from 16/06/2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed on 27.07.2026 which would be by e-auction mode.
