M/s Chandru availed IBHL facility from Indian Bank, Kallakudi Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". M/s Chandru Panneerselvam failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated 13/03/2026 under Sec. 13 (2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling upon Borrower(s), Guarantor(s) **1. Chandru - Borrower, 2. Sellam P – Borrower/Mortgagor and 3. Mutharasu P - Guarantor** liable to the Bank to pay the amount due to the tune of **Rs 695288/- (Rupees Six lakhs Ninety Five Thousand Two Hundred and Eighty eight only)** as on 12/03/2026 with further interest, costs, other charges and expenses thereon. Both failed to make payment despite Demand Notice dated 13/03/2026

As M/s Chandru Panneerselvam failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on 25/05/2026 after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

*As per Rule 9(1) of the Security Interest (Enforcement) Rules 2002, 30 days notice for first sale is required to be given and hence we are issuing this notice.

The amount due as on 23/06/2026 is **Rs.713816/- (Rupees Seven Lakhs Thirteen Thousand Eight hundred and Sixteen Only)** with further interest, costs, other charges and expenses thereon from 24/06/2026.

Please take note that this is notice of 30 days and the schedule mentioned properties shall be sold under the Act by the undersigned/Authorized Officer any time after 30 days.

The date of sale is fixed as 27/07/2026 which would be by e-auction mode.

Inspection of the scheduled properties and related documents/up to date EC etc. by the intending purchasers/bidders may be done at their expense from **29/06/2026 to 24/07/2026** between **10.00 am to 4.00 pm.**

The Reserve price and Earnest Money Deposit (EMD) for the sale of the secured assets is fixed as mentioned in the schedule
