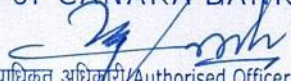
The undersigned proposes to sell the assets more fully described in the Schedule of Sale Notice.

- f) Auction would commence at Reserve Price, as mentioned above. Bidders shall improve their offers in multiplies of Rs.100000/- (Incremental amount/price) mentioned under the column "Increment Combo" (at least select 1). 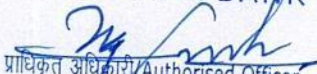
