The dues to the bank as on the date of taking possession was intimated as Rs. **48,60,368/- (Rupees Forty Eight Lakhs Sixty Thousand Three Hundred and Sixty Eight only)** payable together with further interest at contractual rates and rests along with costs, charges etc till date of repayment, after reckoning repayments, if any, since the date mentioned in the demand notice.

After appropriating the repayments if any, the dues in the loan account as on **02.07.2026** is **Rs.57,88,688/87-** (Rupees Fifty Seven Lakhs Eighty Eight Thousand Six Hundred and Eighty Eight and paise Eighty Seven Only) along with further interest at contractual rates and rests, besides costs / charges incurred till the date of repayment in full.

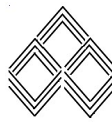

Once the KYC documents are verified by e-auction service provider (may take 2 working days), the intending Bidders /Purchasers has to transfer the EMD amount using online mode in his **Global EMD Wallet account by 22.07.2026 at 5.00 P.M.** Intending bidders shall have a valid email address and should register their name / account by login to the website of the aforesaid service provider.
3. Earnest Money Deposit (EMD) amount as mentioned above shall be paid online through NEFT/RTGS mode (**After generation of Challan from <https://baanknet.com/> which will provide account details**) in bidders Global EMD Wallet account.
