Police said the duo were
in a "partying mood and had
sex multiple times" before
Rajiv strangulated Shilpa to
death. Later, Rajiv partially
chopped the body after cutting
it into pieces and stuffed it in a
large trolley bag to dispose of
it. He kept the body inside the
trolley suitcase until his wife
returned home on February
15, 2018.

Rajiv's wife Manisha, who
was then an SBI assistant
manager, had alerted the po-
lice after she learnt about the
incident on February 15. The
police recovered Shilpa's de-
composed body in a blue suit-
case from the storeroom of
Rajiv's fourth-floor flat in a
multi-storey building in Dur-
gapur.

Rajiv initially told the
police that Shilpa had
committed suicide, but later
admitted to the crime, saying
he was "drunk and angry" at
the time, he said.

The victim's brother San-
dip Agarwal said he had been
shuttling between court and
their home in Bankura's Mejia
for eight years in the hope that
Rajiv would get capital pun-
ishment.

"Our mother fell ill after
the incident and could not
come out of the trauma. We
want capital punishment for
the guilty," said Sandip, who is
physically challenged.
