**Sub : Your Loan Account No.7664396972 of Mr. T. Babu and Mrs. B. Jestina Margaret with Indian Bank, G.N. Chetty Road Branch.**

**Mr. T. Babu and Mrs. B. Jestina Margaret** availed loan facility from Indian Bank, G.N. Chetty Road Branch, the repayment of which is secured by Mortgage of schedule mentioned properties hereinafter referred to as "the Properties". **Mr. T. Babu and Mrs. B. Jestina Margaret** failed to pay the outstanding dues to the Bank. Therefore a Demand Notice dated **17.10.2024** under Sec. 13(2) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002 (for short called as "The Act"), was issued by the Authorized Officer calling **Mr. T. Babu and Mrs. B. As **Mr. T. Babu and Mrs. B. Jestina Margaret** failed to make payment despite Demand Notice, the Authorized Officer took possession of the schedule mentioned properties under the Act on **08.01.2025** after complying with all legal formalities.

As per Sec.13 (4) of the Act, Secured Creditor is entitled to effect sale of the assets taken possession of and realize the proceeds towards outstanding balance. In accordance with the same, the undersigned / Authorized Officer intends selling the schedule mentioned securities in the following mode:

As per Rule 9(1) of The Security Interest (Enforcement) Rules 2002, 15 days notice for subsequent sale is required to be given and hence we are issuing this notice.

The amount due as on **30.06.2026** is **Rs.69,62,489/- (Rupees Sixty nine lakhs sixty two thousand four hundred and eighty nine only)** with further interest, costs, other charges and expenses thereon from **01.07.2026**.
