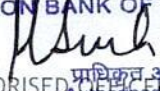
**SUB: Notice of 15 Days for Sale of Immovable Secured Assets Under Rule 8 and 9 of the Security Interest (Enforcement) Rules, 2002 - M/s. Hariom Construction**

1. Union Bank of India, ARB Lucknow, the secured creditor, caused a demand notice dated 07.08.2025 under Section 13(2) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act 2002, calling upon you to pay the dues within the time stipulated therein. Since you failed to comply with the said notice within the period stipulated, the Authorized Officer, has taken **constructive possession** of the immovable secured assets under Section 13(4) of the Act read with Rule 8 of Security Interest (Enforcement) Rules, 2002. Symbolic Possession notice dated 18.11.2025 issued by the Authorized Officer, as per Appendix IV to the Security Interest (Enforcement) Rules, 2002 was delivered to you and the same was also affixed to the properties mortgaged with the Secured Creditor, apart from publication of the same in newspapers. Please note that as per the said demand notice you were informed about your right to redeem the property within the time available under Section 13(8) of Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002.

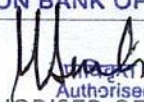
