

However, it went on to allege "selective security operations" and presented a set of demands including an end to "selective security operations" and ensuring that "law enforcement actions are carried out fairly, professionally, and without bias against any community." The council has also demanded that a "firm and decisive action" be taken against "militant groups responsible for attacks" on Kuki-Sao civilians.
